“Today, the debate of whether it is a sin to take the Covid-19 vaccine is becoming a pivotal one. Many are having to choose whether to toe-the-line with governmental demands and the demands from clergy in the Catholic Church, who are urging and agreeing to make it mandatory to take the vaccine; or to stand firm and resist taking the vaccine based on its connection to the intrinsic evil of abortion, as well as many other health issues.”

“The push from the USCCB and bishops across the world to support this experimental COVID vaccine, despite it being tainted with cells from aborted babies, is shocking to many souls. In the least, many are confused on the situation.

Pamala Acker is a biologist and author of the recently released (and extremely informative) book “Vaccination: A Catholic Perspective” [<https://www.kolbecenter.org/product/vaccination-a-catholic-perspective/>] In the book, she reveals precisely how Catholics should be thinking about vaccines. Aker has revealed a very disturbing fact that in the harvesting of cells used for vaccines, they are extracted not from “simple abortion” but that:

“They will actually deliver these babies via cesarean section. The babies are still alive when the researchers start extracting the tissue; to the point where their heart is still beating, and they’re generally not given any anesthetic, because that would disrupt the cells that the researchers are trying to extract. So, they’re removing this tissue, all the while the baby is alive and in extreme amounts of pain. So, this makes it even more sadistic.”

Some claim that taking the vaccine, regardless of it being tainted with aborted baby cells, either through testing or development, is justifiable because of the “extreme danger” of COVID-19. To argue that the “good intention” outweighs the intrinsic evil, some claim that more lives would be saved by the vaccine and that there is no other alternative.

On the contrary, using that logic would be similar to saying that, “giving just a pinch of incense to the Roman gods, would be okay, if lives would be saved in the process.” Yet, that is not what the early Christians did. They refused to give a measly pinch of incense to the fake gods, losing their lives as a consequence. These early Christians and martyrs understood that obeying God’s Commandments was more important than saving their lives, because in their obedience to God they were procuring their eternal life.

Today, that moral line and absolute truth seems to have been blurred to the point that has caused massive confusion among the faithful.

Nevertheless, we must ask ourselves these questions:

Where do we draw the line?

Is killing still a sin?

Is it okay for us to ever be endorsing or using abortion for any means?

Is it ever good to have any collaboration with the fruits of abortion?

Our Faith and common sense clearly tells us the answers to these questions. The health of the body is not the highest and absolute value. Obedience to Divine Law and the eternal salvation of souls must be given primacy, thus determining murder as intrinsically evil in all cases.

Let us be clear about the truth of abortion. Abortion is murder and kills an innocent life.

The 5th Commandment of God is: Thou Shalt not... [Murder].¹

The end does not justify the means. As St. Thomas Aquinas states: "An evil action cannot be justified by reference to a good intention"..."

Alexandra Clark cites The Catechism of The Catholic Church:

CCC 1755: *A morally good act requires the goodness of the object, of the end, and of the circumstances together. An evil end corrupts the action, even if the object is good in itself*

CCC 2258: *"Human life is sacred because from its beginning it involves the creative action of GOD and it remains for ever in a special relationship with The Creator, Who is its sole End. GOD alone is The Lord of life from its beginning until its end: no one can under any circumstance claim for himself the right directly to destroy an innocent human being."*

CCC 2272: Formal cooperation in an abortion constitutes a grave offense. The Church attaches the canonical penalty of excommunication to this crime against human life.

CCC 1750: The morality of human acts depends on:

- the object chosen;
- the end in view or the intention;
- the circumstances of the action.

The object, the intention, and the circumstances make up the "sources," or constitutive elements, of the morality of human acts.

CCC 1751: The *object* chosen is a good toward which the will deliberately directs itself. It is the matter of a human act. The object chosen morally specifies the act of the will, insofar as reason recognizes and judges it to be or not to be in conformity with the true good. Objective norms of morality express the rational order of good and evil, attested to by conscience.

CCC 1753: A good intention (for example, that of helping one's neighbor) does not make behavior that is intrinsically disordered, such as lying and calumny, good or just. The end does not justify the means. Thus the condemnation of an innocent person cannot be justified as a legitimate means of saving the nation. On the other hand, an added bad intention (such as vainglory) makes an act evil that, in and of itself, can be good (such as almsgiving). (Cf. MATTHEW 6:24.)

MATTHEW 6:24

No man can serve two masters. For either he will hate the one, and love the other: or he will sustain the one, and despise the other. You cannot serve GOD and mammon..²

CCC 1754: The *circumstances*, including the consequences, are secondary elements of a moral act. They contribute to increasing or diminishing the moral goodness or evil of human acts (for example, the amount of a theft). They can also diminish or increase the agent's responsibility (such as acting out of a fear of death). Circumstances of themselves cannot change the moral quality of acts themselves; they can make neither good nor right an action that is in itself evil.

The object, intention and action of those producing, promoting, mandating and administering the human aborted baby harvested so called “covid vaccines” meet none of the tests set forth by Holy Mother Church in Her Catechism – as revealed by The Almighty through His Holy Scriptures and interpreted with unbroken righteousness in The Moral Law of GOD by Biblical Israel and The Catholic Church – to justify their reception by mankind, and especially by faithful Catholics. Our Redeemer quotes Moses:

MATTHEW 22:36-40

³⁶ Master, which is The Greatest Commandment in The Law?

³⁷ JESUS said to him: Thou shalt love The LORD thy GOD with thy whole heart, and with thy whole soul, and with thy whole mind. ³

³⁸ This is The Greatest and The First Commandment.

³⁹ And The Second is like to this: Thou shalt love thy neighbour as thyself. ⁴

⁴⁰ On These Two Commandments dependeth The whole Law and the prophets. ⁵

Ms. Clark quotes Catholic Archbishop Carlo Maria Vigano (former Apostolic Nuncio to the USA), reminding us of The Divine Truth revealed to mankind since The Garden of Eden, that since human life is created in The Image of The Creator Himself, it is of inestimable value:

³ DRA, DEUTERONOMY 6:4-5: Hear, O Israel, The LORD our GOD is one LORD. Thou shalt love The LORD thy GOD with thy whole heart, and with thy whole soul, and with thy whole strength.

⁴ DRA, LEVITICUS 19:18: Seek not revenge, nor be mindful of the injury of thy citizens. Thou shalt love thy friend as thyself. I AM The LORD.

“this battle for the family is **the defense of life from conception to natural death. The crime of abortion**, which has claimed millions of innocent victims and that cries out for vengeance from Heaven, is today considered as a normal health service, and just in recent days the Italian government has authorized the more widespread use of the abortion pill, encouraging **an abominable crime...**”

GENESIS 1:27

And GOD created man to His Own Image: to The Image of GOD He created Him: male and female He created them. ⁶

Ms. Clark further quotes Catholic Bishop Athanasius Schneider (Bishop of Astana, Kazakhstan), who compares correctly the current day worldwide pandemic sanitary dictatorship to that of the heavy hand of the now defunct communist Soviet Union, which has seemingly been resurrected by satanic forces in the form of the present oppressive covid health tyranny and the so called “covid vaccine,” a form of a mark of the beast warned of by St John:

"one of the greatest evils of mankind, the cruel genocide of unborn. We will be marked. **We will receive a sign in our body which will in any way and some way demonstrate that we are connected to this greatest, one of the greatest evils.** ...Because to accept in some way the fruits of the abortion and all of these horrible testing and production of cell lines, it is really horrible, and then when all the people of the earth will have this sign in their body, which is a sign of death, ultimately. No matter what twisted compromises and outright rejections of The Faith put forth by the current Pope, Bishops and other Clergy throughout The Catholic Church today, there can be no compromise on the GOD-ordained sanctity of human life from conception to natural death. Ms. Clark quotes Catholic Bishop Joseph E. Strickland (Bishop of Tyler, Texas, USA):

“From a moral point of view, for every Catholic who intends to remain faithful to his or her Baptism, **it is absolutely inadmissible to accept a vaccination that utilizes material {the body} coming from human fetuses in its process of production.** This has also been restated authoritatively by the Bishop Strickland in his April 27 Pastoral Letter...”

For even before The King of The Universe called each human being into conception in the wombs of our mothers, each most miniscule portion of our physical and spiritual creation was pre-known and written in the book of life in Heaven by He Who is I AM THAT I AM:

¹⁵ My substance was not hid from Thee, when I was made in secret, and curiously wrought in the lowest parts of the earth.

¹⁶ Thine eyes did see my substance, yet being imperfect; and in Thy book all my members were written, which in continuance were fashioned, when as yet there was none of them. ⁸
